- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.

Increase in number of students should be granted subject to following condition:

1. The College will strictly adhere to the State Government reservation policy applicable for admission purpose.
2. If the College requested less number of students to increase then the decision taken by the Committee, actual number of seats requested for shall be granted.
3. The last date of admission should be follow as per University Circular issued time to time but not later than declared date.
4. Admission to the additional seats permitted should be strictly on the basis of merit and appropriate reservation quota as may be applicable.
5. There shall be **no management quota** for these additional seats.
6. Colleges eligible for assessment and accreditation should give an undertaking to initiate the necessary process for the same.
